

# “Hello I’m Flo’s Font”

## End User License Agreement: **Print & Web**

As used herein, “Font Software” means coded and encrypted Software that generates typeface designs when used with the appropriate hardware and software. “Hello I’m Flo” grants you a non-exclusive licence to use the Software and Documentation, provided that you agree to the following:

### **Rights:**

“Hello I’m Flo” reserves all rights to intellectual property contained within.

Rights written, common law rights, unwritten and the possible evolution of future rights yet to be invented and/or rights for uses in yet to be invented technologies are all reserved by Hello I’m Flo.

Upon purchase “Hello I’m Flo” grants you (The Licensee) a non-exclusive license to use the font software within the terms, conditions and restrictions of this agreement.

### **By purchasing and/or installing “Hello I’m Flo’s Font”’s software you agree to the following terms:**

#### **1. Number of users:**

The “Hello I’m Flo’s Font” Software is licensed for use at one (1) location with a maximum of five (5) users.

Use of the “Hello I’m Flo’s Font” Software at more than one (1) location or with more than five (5) users requires a Multi-Device Site Licence upgrade.

*This means that the standard licence allows only 5 users to use the fonts.  
If more users plan to use the fonts, you need to upgrade the licence to cover multiple users.*

#### **2. Modifications:**

You may import characters from the font as graphical objects into a drawing program and modify such graphical objects. You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the licensed font itself without Foundry’s prior written consent.

*This means that you may not modify the fonts in any way.*

#### **3. Rights reserved:**

The Font Software and the designs embodied therein are the exclusive property of Hello I’m Flo. This non-exclusive, revocable licence grants you certain limited rights to use the font software only, no permanent or ownership rights are granted as a part of this contract herein. All right, title and interest in and to the font software, the designs of the fonts embodied therein together with the copyrights, trademarks, trade names and service marks associated with the font software are each the exclusive property of Hello I’m Flo.

*This means that by buying the licence you only buy the right to use the fonts.  
The fonts themselves remain the exclusive property of Hello I’m Flo.*

#### **4. Derivative work:**

Any derivate works created by you which use or are based upon the font software and/or the designs of the fonts, including, but not limited to, software or other electronic works, are considered derivative works under the Law of Belgium. Any such derivative works are the exclusive property of “Hello I’m Flo” and shall be subject to the terms and conditions of this licence. Derivative works may not be sublicensed, sold, leased, rented, loaned, or given away without the express written permission of Hello I’m Flo. “Hello I’m Flo” shall not be responsible for or required to support unauthorised, modified and/or regenerated software or derivative works. You are permitted to convert the Fonts to outline or bitmap images for the purposes of publishing electronic documents.

*This means that you can’t create other fonts based on our fonts.  
You also cannot sell or rent modified versions of our fonts.*

#### **5. Third party use, broadcasting:**

This Print & Web Licence permits a printer, designer or service bureau to access and work with the font software. It is therefore valid only for output of that customer’s jobs.

If you are an advertising agency, acting on behalf of an advertising agency or otherwise acting in a similar capacity or for the benefit of a third party. The font software or a copy thereof will be transmitted to the client or third party, the purchase of a licence for or by your client is required. Depending upon how the Font Software will be used, an additional licence upgrade and/or the purchase of a special licence may be required. If you are using the Font Software in exhibition or display in cinemas, motion pictures, on television or on cable television, or as a part of any works broadcast or transmitted on the Internet, a special broadcasting licence is required and an additional licence fee may be required.

*This means that you need a special licence if you plan to embed the fonts in hardware or software, or if you will use the fonts in videos or movies.*

## 6. Copyright:

The "Hello I'm Flo's Font" Software is protected under domestic and international trademark and copyright law.

The end user of this license agrees to do its best to credit "Hello I'm Flo" in conformity with the code of intellectual property, international conventions and to the copyright regulations by indicating in the colophon or/and any place where credits and the printer name appear:

Digital font name, ©Hello I'm Flo.

*This means that you have to identify the Hello I'm Flo's fonts by name in any design or production credits.*

## 7. Termination of Agreement:

Any breach of the terms of this Agreement shall be cause for termination. In the event of termination, and without limitation of any remedies under law or equity, you agree to immediately return the Font Software to "Hello I'm Flo" and certify that no copy remains in your possession or control.

*This means that if you violate these terms, this agreement will be cancelled.*

## 8. Product Upgrades:

"Hello I'm Flo" may, from time to time, update the Product. Product upgrade pricing may apply.

## 9. Transferring the licence:

You may transfer the Font Software to another party provided that the new licensee agrees in writing to be bound by this licence, and you destroy all copies of the Font Software immediately upon transfer of the Font Software.

The new licensee must transmit a copy of their Agreement to Hello I'm Flo.

*This means that you may transfer the font licence to a third party if he agrees to the licensing conditions in writing and you destroy your copies of the fonts (and confirm this in writing too).*

## 10. Warranties:

"HELLO I'M FLO" MAKES NO WARRANTIES, EXPRESS OR IMPLIED, AS TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, OR OTHERWISE. THE FONT SOFTWARE WAS NOT MANUFACTURED FOR USE IN MANUFACTURING CONTROL DEVICES OR NAVIGATION DEVICES OR IN CIRCUMSTANCES THAT COULD RESULT IN ENVIRONMENTAL DAMAGE OR PERSONAL INJURY. WITHOUT LIMITING THE FOREGOING, "HELLO I'M FLO" SHALL IN NO EVENT BE LIABLE TO THE LICENSED USER OR ANY OTHER THIRD PARTY FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING DAMAGES FROM LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION OR LOSS OF BUSINESS INFORMATION, ARISING OUT OF THE USE OR INABILITY TO USE THE PRODUCT EVEN IF NOTIFIED IN ADVANCE. UNDER NO CIRCUMSTANCES SHALL "HELLO I'M FLO"'S LIABILITY EXCEED THE SUBSTITUTION OR REPLACEMENT COST OF THE FONT SOFTWARE, WHICHEVER IS LESS, AND AT THE SOLE DISCRETION OF "HELLO I'M FLO". THE TERMS OF THIS LICENCE AGREEMENT ARE CONTRACTUAL IN NATURE.

The "Hello I'm Flo" Font Software licence Agreement is subject to Belgian Law. By downloading and installing the Fonts, you acknowledge that you have read, understood, and agreed to be bound by the terms and conditions of this licence Agreement.

*This means that we can't guarantee that the fonts will be appropriate for your projects*
